**Parental Consent and Release Form

GENERAL OVERVIEW

I, the undersigned, am the parent or legal guardian of the Minor named below.

As the parent or legal guardian of the Minor, I certify and affirm that I have been completely and thoroughly informed that by attending the Beta Sports Tournament described on this form, my child will likely (but not necessarily be required to) participate in certain activities associated with a typical e-sports tournament including, but not limited to, ranked video game competition, awards ceremonies, social interaction with gamers of all ages and backgrounds, on-camera interviews, various e-sports related games, various e-sports related trivia, various e-sports related “easter-egg” hunts, social media pop-ups, and more, including spontaneous activities and interactions, as is the nature of this type of event, the specific and comprehensive scope of which could not possibly be predicted by Beta Sports or any Beta Sports representative prior to the event actually taking place.

LIABILITY WAIVER

While I understand that Beta Sports is pleased to offer this exciting event as an “ALL AGES” event and while Beta Sports also strives to create a safe environment for all attendees; within the allowable scope of the law, I personally assume, on my child's behalf, all risk in connection with the Beta Sports Tournament described on this form for any harm, injury, or damages that may befall my child as a result of my child's participation in the Beta Sports Tournament described on this form, whether foreseen or unforeseen, and I still wish to allow my child to participate in the Beta Sports Tournament described on this form.

In consideration of my child being allowed to participate in the Beta Sports Tournament described on this form and to use Beta Sports equipment and corresponding facilities/venues, on behalf of my child, and as to myself as parent and legal guardian, I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless Beta Sports, the company, its officers, directors, employees, volunteers, agents, and contractors from any and all claims, demands, or causes of action, which are in any way connected with my child's participation in the Beta Sports Tournament described on this form or use of the Beta Sports equipment and corresponding facilities/venues.

While I understand that Beta Sports is striving and committed to creating and nurturing a “family-friendly” environment, I understand that my child will likely be interacting with participants, venue representatives, vendors and others of all ages and Beta Sports can in no way guarantee the behaviors of dozens of participants whom they have never met and that my child may hear or see something that would otherwise be cringe-worthy or inappropriate for someone of their age and I still feel like my child is mature enough to handle themselves appropriately in the unlikely event this should happen but will not hold Beta Sports responsible for this interaction.

AUDIO/VIDEO/STILL FRAME CAPTURE PRODUCTION WAIVER

I understand, in consideration of my child's participation in the *Beta Sports Tournament described on this form (*hereafter, referred to as "Event"), and without any further consideration from myself or my child, I hereby grant permission to Beta Sports and any representatives it sees fit, to utilize my child's appearance in connection with the Event in any and all manner and media and all rights of every kind and character whatsoever in perpetuity in and to my child's performance, appearance, name and/or voice and the results and proceeds thereof in connection with the Event, and I hereby authorize Beta Sports to photograph and record (on film, digital, video, tape, or otherwise), the Event; to edit same at its discretion and to include it with the performance of other Event participants and with sound effects, special effects and music; to incorporate same into the Event or other program or not; to use and to license others to use such recordings and photographs in any manner or media whatsoever, including without limitation unrestricted use for purposes of publicity, advertising and sales promotion; and to use my child's name, likeness, voice, biographic or other information concerning my child in connection with the Event, commercial tie-ups, merchandising, and for any other purpose. I further acknowledge that Beta Sports owns all rights to the results and proceeds of mine and my child's services rendered in connection with the Event and herewith.

I agree that my child's participation in the Event may be edited at Beta Sports sole discretion. I consent to the use of my child's name, likeness, voice and biographical material about my child in connection with Event publicity and related institutional promotional purposes. I expressly release Beta Sports and any affiliates it deems appropriate, including, but not limited to, agents, employees, licensees and assigns from and against any and all claims which I or my child have or may have for invasion of privacy, defamation or any other cause of action arising out of production, distribution, broadcast or exhibition of any material related to Event.

IN CASE OF EMERGENCY

In cases of emergency, I further consent to the examination or treatment of my child by a physician duly licensed to practice medicine or any health care professional duly licensed to provide health care services, for medical care and services deemed necessary by Beta Sports or its representatives at the advice of said physician(s). In the event that it is not possible to acquire the services of a physician or health care provider to diagnose and treat my child based upon the existing circumstances, I also consent to the employees, volunteers, and representatives of Beta Sports to use their best judgment to provide assistance until a physician or health care provider can be obtained.

I give permission to the physician or health care professional to provide any and all medical care they deem, in their professional opinion, to be necessary.

I agree to pay for any and all medical expenses incurred as a result of the use of this consent.

I understand that it is my obligation to inform Beta Sports of any and all behavioral, health considerations, or medical conditions that would affect or restrict my child's participation in the Beta Sports Tournament described on this form. I will not allow my child to participate in any specific programs of the Beta Sports Tournament described on this form which I know or should know would jeopardize my child's health or safety based upon my child's existing behavioral, medical or health

condition that would subject themselves or other tournament participants or anyone else to danger, disease or illness.

I understand that, in the unlikely event the need for medical attention arise, a Beta Sports representative will attempt to contact me as soon as practicable under the specific circumstances that arise.

LIABILITY OF POTENTIAL DAMAGES

By signing this document, I acknowledge that if anyone is hurt or property is damaged as the result of the Minor's actions during the Beta Sports Tournament described on this form, the Minor and I may be found personally liable for the damages considering the Minor is not a legal adult by law.

BINDING

I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect. By signing I am stating that I have fully informed myself of the contents of this **Parental Consent and Release Form for Beta Sports Tournament as Described at the Bottom of this Form** by reading it before I signed it. I warrant that I possess all the rights, powers, and privileges of a parent or legal guardian necessary to execute this document with binding legal effect.
